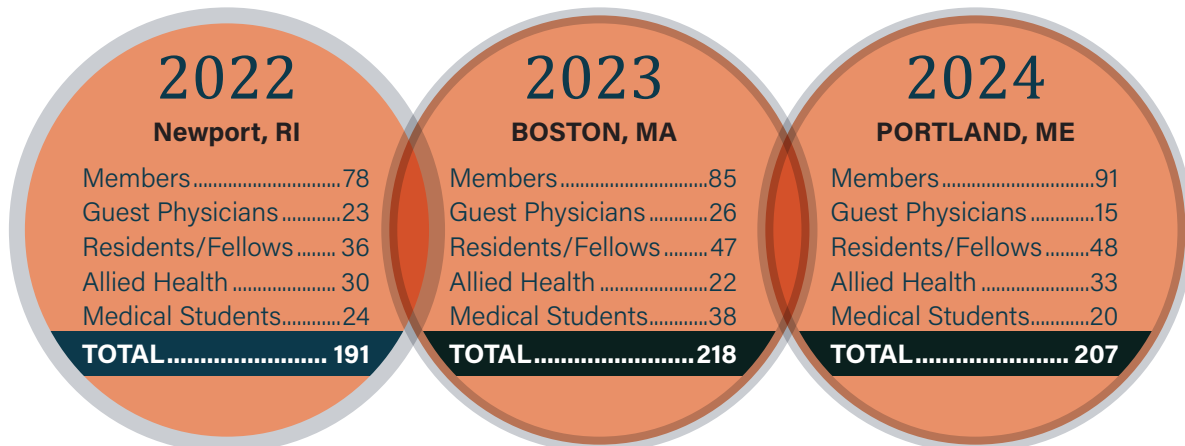

INSTALLATION/DISMANTLING

All exhibits must be set between 4:00 pm - 6:00 pm on Thursday, October 24, 2025. Set-up during scheduled exhibit hours will not be permitted.

SPACE ASSIGNMENT

Preferred space will be given to Annual Meeting sponsors (if application is received by the posted deadline of Wednesday, September 18, 2025). After this deadline, all other companies will be assigned in the order in which the applications were received. Exhibitors wishing to avoid assignment of space adjacent to a particular company should indicate this on their application. Careful consideration will be given to such requests, but cannot be guaranteed. The NESVS has the right to alter the floor plan at any given date/time.

SHIPPING INFORMATION

Shipping information will be emailed to exhibiting companies after the deadline.

SECURITY

The safekeeping of the exhibitor's property shall remain the responsibility of the exhibitor. The New England Society for Vascular Surgery and Omni Providence Hotel Harborview are not responsible for theft, loss or damage that may occur and advise each exhibitor to insure their stands, equipment and materials at full value.

Electrical or other mechanical apparatus must be muffled so noise does not interfere with other exhibitors. Character of the exhibits is subject to approval of the conference organizers. The right is reserved to refuse applications of concerns not meeting standards required or expected, as well as the right to curtail exhibits or parts of exhibits, which reflect against the character of the meeting. This applies to displays, literature, advertising, novelties, souvenirs, conduct of person, etc.

LIABILITY
